

The Adams County Board of Supervisors met on Monday, June 28, 2021 at 9:00 am with the following members present: Bobbi Maynes, Leland Shipley, Doug Birt, Merlin Dixon, and Scott Akin. The meeting was called to order by Chairperson Maynes. Birt moved, seconded by Akin to approve today's agenda along with the minutes from June 21, 2021. All supervisors voted aye. Motion carried.

Engineer Travis Malone gave an update on the Secondary Roads department. The limestone rock is wrapping up this week. Bridge on 110th had its back walls removed and is ready to begin pile driving. Due to the recent weather pile driving is delayed until the dirt roads become passable to move the cranes in. The bridge on 180th was to have the precast, prestressed, concrete beams set last Friday but with the rain and storms that was delayed until today.
