Motion carried and the hearing was closed at 10:06 AM. Birt moved, seconded by Peckham, to adopt the FY12/13 Budget with a levy rate reduced from the published amount because of changes in mental health. Ayes: Birt, Mullen McCarty, Peckham, England. Nays: none. Motion carried. Said Resolution was assigned #03132012 in the Resolution Book. A complete copy is available for public inspection in the Auditor's office during regular business hours.

The Supervisors discussed the possibility of pursuing a contract with the McDermott Center for substance abuse care. The consensus was favorable to move forward. No votes were taken.
