

The Adams County Board of Supervisors met in regular session on Tuesday, April 17, 2012, with the following members answering roll call: Linda England, Karl McCarty, Phyllis Mullen, Jerry Peckham and Doug Birt. The meeting was called to order by Chair. The agenda for the day was read and approved.

Wes Ray, Adams County Assessor, discussed the effect of the new wind turbines value on property taxes. No votes were taken.

Lisa Brown and Scott Russell updated the Supervisors regarding completed and upcoming training for the Adams County Emergency Response Association. They discussed having written a grant for equipment needs. Following a discussion regarding use of a federally funded mass casualty trailer, the Supervisors asked that the County Attorney be involved. No votes were taken.

The Supervisors had a discussion regarding several Employee Handbook issues. No votes were taken.

Mullen moved, seconded by Peckham, to approve a Fireworks Permit for Midland Pyrotechnics Association to be held at 1342 Hickory Ave., Corning. Ayes: Birt, Mullen, Peckham, McCarty, England. Nays: none. Motion carried.

McCarty moved, seconded by Birt, to approve a 28E Agreement with Southern Iowa Trolley. Ayes: Birt, Mullen, Peckham, McCarty, England. Nays: none. Motion carried.

Birt moved, seconded by Peckham, to approve an agreement for Involuntary Admission Services with Alegent Health-Bergan Mercy Health System. Ayes: Birt, Mullen, Peckham, McCarty, England. Nays: none. Motion carried.

Following discussion, McCarty moved, seconded by Mullen, to set a Public Hearing date for 10:00 AM on Tuesday, May 1, 2012, to receive comments relating to an Incentive Zoning Permit. Ayes: Birt, Mullen, Peckham, McCarty, England. Nays: none. Motion carried.

Mullen moved, seconded by Peckham, to approve by Resolution, the placement of a stop sign at the intersection of Holly Road and the west approach of Quincy Trail located near the NE corner of the SE 1/4 SE 1/4 of Sec. 17, Township 72-N, Range 34W. Ayes: Birt, Mullen, Peckham, McCarty, England. Nays: none. Motion carried and said Resolution was assigned #04172012 in the Resolution Book and is available for public inspection in the Auditor's Office.

Birt moved, seconded by McCarty, to approve a Utility Permit Application 12-03 from Mediacom for the installation of fiber optic cable. Ayes: Birt, Mullen, Peckham, McCarty, England. Nays: none. Motion carried.
