England moved, seconded by Dixon, to purchase a loader for Secondary Roads. All supervisors voted aye. Motion carried. Family Farm Tax Credit was tabled until the annual review.

Mullen moved, seconded by England, to set the public hearing to discuss selling the Nevinville property for July 9. All supervisors voted aye. Motion carried.

Mullen moved, seconded by England, to appoint Jerry Peckham and Jessica Wilson to serve on the Compensation Board. All supervisors voted aye. Motion carried.

Mullen moved, seconded by McCarty, to transfer \$32,500 from the General Basic Fund to the Conservation Reserve Fund. All supervisors voted aye. Motion carried.

Dixon moved, seconded by England, to approve issuing checks in lieu of warrants starting July 1, 2013. All supervisors voted aye. Motion carried.

Discussion regarding a county-held tax sale certificate. No action was taken.
