

The Adams County Board of Supervisors met in regular session on Tuesday, August 12, 2014, with the following members present: Karl McCarty; Linda England, Phyllis Mullen, and Merlin Dixon. Doug Birt was absent. The meeting was called to order by the Chair, Dixon. The agenda for the day was read and approved.

Chris Heimke gave an update on Hearts & Hugs Daycare and their need to find another location for the daycare. They shared their interest in purchasing a building to renovate and use. They explained they are seeking donations and pledges from the community and asked the board to make a 5-year pledge of \$5,000.00 per year. The board explained this year was already budgeted and would not be able to pledge that and when budget time came around again they needed to request it then. No action was taken.
