

The Adams County Board of Supervisors met at 9:00 am on Tuesday, October 7, 2014, with the following members present: Karl McCarty; Doug Birt, Linda England, Phyllis Mullen, and Merlin Dixon. The meeting was called to order by the Chair, Dixon. The agenda for the day was read and approved.

Chris Heimke and Beth Waddle gave an update on the Hearts and Hugs moving locations. They asked the board for a county guaranty not to exceed \$85,000 for a loan between the daycare and Southwest Iowa REC. England moved, seconded by Mullen. All supervisors voted aye. Motion carried.
