

The Adams County Board of Supervisors met at 9:00 on Friday, January 2, 2015 with the following members present: Doug Birt, Merlin Dixon, Linda England, Karl McCarty and Leland Shipley. Auditor, Rebecca Bissell called the meeting to order. The Oath of Office for the newly elected officials was administered by Clerk of Court Jennifer Dingman. The following officials received the oath: Jamie Stargell – Recorder; Nancy Kempton - Treasurer; Doug Birt – Supervisor; Linda England – Supervisor; Leland D. Shipley - Supervisor; Jen Shires- Deputy Auditor; Deb Olive- Deputy Recorder and Linda Hughes – Deputy Treasurer.

Birt moved, seconded by Shipley to appoint Karl McCarty as the Chairperson of Board of Supervisor for 2015. All supervisors voted aye. Motion carried. McCarty then took control of the meeting. Birt moved, seconded by Dixon to appoint Linda England as Vice Chairperson of the Board of Supervisors for 2015. All supervisors voted aye, motion carried.

Birt moved, seconded by England to make the Adams County Free Press the official newspaper for the year 2015. All supervisors voted aye. Motion carried. Birt moved, Shipley seconded to issue checks during the year 2015 per Section 331.506 of the 2013 Code of Iowa. All supervisors voted aye. Motion carried. England moved, seconded by Shipley to set the mileage at \$.50 per mile effective January, 2015. All supervisors voted aye, motion carried

Dixon moved, seconded by England to reappoint Jerry L Peckham, Kathy West and Nicci Tucker to 1-year terms on the Human Services Board. All supervisors voted aye, motion carried. Birt moved, seconded by Shipley to be reappoint Virgil James as the weed commissioner for a 1-year term to expire 02/28/2016. Motion carried with 4 aye votes, England abstained. Birt moved, seconded by England to reappoint Bill Shipley to a 5-year term to expire December 31, 2019 to the Conservation Board. Motion carried with 4 ayes, Shipley abstained.

Birt moved, seconded by England to reappoint Dr. Maen Haddadin to a 1-year term as Medical Examiner. All supervisors voted aye, motion carried. England moved, seconded by Shipley to reappoint Dr. Bethel Kopp as Assistant Medical Examiner. All supervisors voted aye, motion carried. England moved, seconded by Birt to reappoint Lisa Brown to a 1-year term as Medical Examiner Investigator. All supervisors voted aye, motion carried. England moved, seconded by Birt to reappoint Hartford Cooper and Maria Fuller to a 3-year term to expire 12/31/2017 on the Board of Health. All supervisors voted aye, motion carried.

Birt moved, seconded by Dixon to reappoint Sharon (Mrs. Larry) Walter to a 5-year term to expire December 31, 2019 to the Zoning Board of Adjustment. All supervisors voted aye, motion carried. England moved, seconded by Shipley to reappoint Rob Tucker and Carolyn Dixon to a 2-year term to expire December 31, 2016 to the Zoning Commission. 4 ayes, Dixon abstained, motion carried.

Birt moved, seconded by England to reappoint Merlin Dixon, Supervisor Representative, to a 1-year term to expire December 31, 2015 to the Citizen's Advisory Board. All supervisors voted aye, motion carried.

England moved, seconded by Shipley to make the following 1-year appointments to the Condemnation Board. All supervisors voted aye, motion carried.

Birt moved, seconded by England, to approve the General Relief Assistance Guidelines as follows: Rent: As Needed; Utilities: As Needed. Current only; Food: Food Vouchers not to exceed 5 in one year; Prescription: Not to exceed \$300 per month. Prescription must be provided; Dental: Not to exceed \$200 for extractions and \$350 for dentures; Glasses: Paid per invoice; Medical Bills: Payment made only to local vendors for necessary medical care if no other resource is available; Burials: \$1,000 for cremation. Maximum Limitations for a needy household unit shall not exceed \$1,000 per 12-month period unless specifically authorized by the Adams County Board of Supervisors by resolution. Recipients of General Assistance must be Adams County residents. All supervisors voted aye. Motion carried.
