

The Adams County Board of Supervisors met at 9:00 am on Tuesday, March 10, 2015, with the following members present: Doug Birt, Linda England, Leland Shipley, Merlin Dixon, and Karl McCarty. The meeting was called to order by the Chair, McCarty. The agenda for the day was read and approved.

Dan Carl discussed with the board the funds needed for all their projects. The board is trying to get a final amount to bond for to cover all expenses for all projects.
