The Adams County Board of Supervisors met at 9:00 am on Tuesday, March 31, 2015, with the following members present: Doug Birt, Linda England, Leland Shipley, Merlin Dixon, and Karl McCarty. The meeting was called to order by the Chair, McCarty. The agenda for the day was read and approved.

Bert Peckham and Wayne Moore spoke to the board with regards to the construction of the fire station causing damage to the County Sheriff's play pen. They said they wanted to do what was right by the county, but they weren't sure if the damage was caused by the construction of the fire house. The board said they have to go by the Jail Inspector's recommendations. The board, Peckham, Moore, and Sheriff Johannes took a site visit to the play pen to see the damage the inspector had pointed out before. Johannes said he'll get the jail inspector to come back, give a recommendation, and then he'll present that to the Board. Everyone agreed to wait for further action until the jail inspector returns.

The board is sending a letter to Senator Shipley and Representative Drake in regards to supporting Senate File 403, which uses resources in the E911 Wireless surcharge for its intended purpose at the local Public Safety Answering Point (PSAP). In the letter they also state they strongly discourage House File 560 that will try to divert the funds away from local 911 centers and go to the DPS and DOT for a new 700 mhz radio system.

Shipley moved, seconded by Birt to award contract to Murphy Heavy Contracting Corp for Project BRS-C002 (62) - -60-02 the Mt Etna Bridge. Their bid was the lower bid of \$1,106,633.55. All supervisors voted aye. Motion carried.

Birt moved, seconded by Shipley to approve the Auditor's Quarterly Report. All supervisors voted aye. Motion carried.

The board allowed and disallowed the Family Farm Tax credit Applications.
