

The Adams County Board of Supervisors met at 9:00 am on Tuesday, May 12, 2015, with the following members present: Doug Birt, Linda England, Leland Shipley, Merlin Dixon, and Karl McCarty. The meeting was called to order by the Chair, McCarty. The agenda for the day was read and approved.

Shipley moved, seconded by Birt to award the contract for the Bridge Replacement Project BROS-C002 (66)-8J-02 to Gus Construction Co, Inc. of Casey, IA. All supervisors voted aye. Motion carried.

Dixon moved, seconded by Shipley to set the Public Hearing for May 26<sup>th</sup> at 10:00 am for the FY14-15 Budget Amendment. All supervisors voted aye. Motion carried.

Beth Waddle and Donna Hogan gave an update on the Spec Building. ACED was able to make a payment of \$75,193.58 toward the spec building loan, therefore, reducing the loan payments. Beth presented some revised loan payoff schedules to the board for consideration.

The Board tabled the sewer hookup fees for the Lake Sewer line until further discussion with the County Attorney Zimmerman.

England moved, seconded by Dixon to approve the amendment to the Cass County contract with FY16 budget for the Child Support Recovery Unit. All supervisors voted aye. Motion carried.

England moved, seconded by Birt to approve the weed notice to all property owners pursuant to the provisions of Chapter 317, Code of Iowa, that each owner and each person in possession or control of any lands in Adams County shall cut, burn, or otherwise destroy all noxious weeds. All supervisors voted aye. Motion carried.

England moved, seconded by Shipley to approve the Country Haven Contractor's Application for Payment No. 1 for \$49,700.50. All supervisors voted aye. Motion carried.
