

The Adams County Board of Supervisors met in regular session at 9:00 am on Tuesday, June 28, 2016, with the following members present: Leland Shipley, Merlin Dixon, Linda England, Karl McCarty and Doug Birt. The meeting was called to order by Chairperson England. The agenda for the day was read and approved.

Sheriff Johannes discussed with the board his concerns about certain budget line items and the fund his salary is deducted from. Auditor Bissell has confirmed with the State Auditor's office that the sheriff's salary should not be paid out of fund 02000 as it was previously budgeted. She also confirmed that communications expenses could be moved to fund 02000. Auditor Bissell said she would help Sheriff Johannes getting the account lines changed.

Dixon moved, seconded by Shipley to approve the liquor license LC0006376 for Happy Hollow Country Club. All supervisors voted aye. Motion carried.

McCarty moved, seconded by Shipley to approve the Utility Permit 16-08 for Frontier Communications near the Lenox area on parts of Union Ave, Quince Ave, and 200th St. Motion carried.
