

The Adams County Board of Supervisors met in regular session at 9:00 am on Tuesday, September 13, 2016, with the following members present: Linda England, Leland Shipley, Doug Birt, Merlin Dixon and Karl McCarty. Also in attendance Sheriff Alan Johannes. The meeting was called to order by Chairperson England.

Updating the County Ordinances was tabled.

Sheriff Alan Johannes updated the board on the additional costs that will be associated with the hiring of a new deputy. There will be the cost of a new vehicle and other equipment costs that will need to be included in the total cost of a new hire. Johannes said he's just begun to look into pricing and he estimates it to be around \$70,000. No action was taken.

Birt moved, seconded by Dixon to approve Resolution 2016- 28 to abate the taxes of a building on leased land that has been removed from the property as there is no way of collecting the taxes. All supervisors voted aye. Motion carried.
