

Board Minutes June 27, 2017

The Adams County Board of Supervisors met on Tuesday, June 27, 2017, at 9:00 AM with the following members present: Merlin Dixon, Linda England, Karl McCarty, Doug Birt, and Leland Shipley. Also in attendance were Kathy Peckham, Jan Sickles, Billi Vavra, Alan Johannes, and Mark Saylor. The meeting was called to order by Chairperson Shipley. The agenda for the day was read and approved.

Kathy Peckham spoke with the board about the possibility of creating a satellite ambulance service at Prescott. Billi Vavra, of Prescott Fire and Rescue, is now responsible for the ambulance and has approached Jan Sickles about helping to administer the paperwork. Jan explained to the board that she has administered satellite locations in Clearfield and Blockton in Taylor County and would be willing to do the same in Prescott. The board would be in support if the Prescott City Council approves an agreement.

Ralph Neill spoke to the board concerning preventative maintenance on tubes and bridges as well as controlled burns in the county. In the last eight years there have been four controlled burns on neighboring properties that have gotten out of hand and have raged across his land causing damage to his property. He has lost fences and has had other damage and he wants it to stop. He recommended a burn ban three months of the year or have a fire department monitor the burn to keep it contained and have the cost be borne by the land owner for the fire department's time. The board will consult with County Attorney Knuth for available options.
