

Board Minutes July 11, 2017

The Adams County Board of Supervisors met on Tuesday, July 11, 2017, at 9:02 AM with the following members present: Merlin Dixon, Linda England, Karl McCarty, Doug Birt, and Leland Shipley. Also in attendance were, Alan Johannes, Joan Gallagher, and Mark Saylor. The meeting was called to order by Chairperson Shipley. The agenda for the day was read and approved.

Birt moved, seconded by McCarty to reappoint Jessica Wilson and Jerry Peckham each for a 4-year term as the Board's representatives to the Adams County Compensation Board pending their acceptance. All supervisors voted aye, motion carried.

Joan Gallagher, Taylor County Public Health, appeared before the board to give an update. She is going to try to come and update the board on a monthly basis. Funding was approved for FY 17/18. They are having issues with their Frontier connection and hope to have it worked out soon. A recent survey taken with patients received complimentary remarks. Currently, they are set up on a quarterly payment system with the county and would like the board to consider changing that to a monthly reimbursement.

Sheriff Johannes appeared before the board regarding one of the dispatchers recent pay increases. He assumed that the new rate was a certain amount and then a cost of living adjustment would be added to that. The Board of Supervisors thought that in the future they would revisit the caps every year.
