The Adams County Board of Supervisors met on Tuesday, Aug 8, 2017, at 9:00 AM with the following members present: Linda England, Karl McCarty, and Doug Birt. Also in attendance were Donna Hogan, Nancy Kempton, and Mark Saylor. The meeting was called to order by Vice-Chairperson Birt. The agenda for the day was read and approved.
