

Board Minutes September 25, 2017

The Adams County Board of Supervisors met on Monday, September 25, 2017, at 9:00 AM with the following members present: Merlin Dixon, Linda England, Karl McCarty, Doug Birt, and Leland Shipley. Also in attendance were Nancy Kempton, Alan Johannes, Andy Knuth, Tim Kirgan, Ed Morrison, Jayne Templeton, Katrina Ogburn, and Mark Saylor. The meeting was called to order by Chairperson Shipley. The agenda for the day was read and approved.

Discussion was held with Sheriff Alan Johannes regarding medical invoices for inmates that he has received recently. Sheriff Johannes received an invoice for an inmate that sought medical treatment while being incarcerated. Sheriff Johannes shared he has met with Lisa Wolfe at CHI concerning options and Sheriff Johannes didn't think we had any recourse other than to pay the invoice as presented. He discussed with County Attorney Andy Knuth the possibility of an ankle monitoring system. They were going to look into this and report back to the board.

England moved, seconded by Dixon to approve a wage increase for the Election/Real Estate Clerk in the Auditor's office to \$17 per hr. All supervisors voted aye. Motion carried.

Discussion was held regarding surveying the County Farm. They are going to have another section surveyed off to be able to keep possession of the sewer shed.

Ed Morrison and Tim Kirgan with Iowa Municipalities Workers' Compensation Association (IMWCA) and Jayne Templeton and Katrina Ogburn with Miltner Insurance gave a five year history of our claims and what we need to continue to do to keep employees safe and to maintain our low rates.
