The Board of Supervisors, under the authority of the 2021 Code of Iowa, formed a canvassing board to check the returns of the City/School held on November 2, 2021. The findings, thereof, are record at length in Election Book #8 in the Adams County Auditor's Office as required by Section 50.27 of the 2021 Code of Iowa. No obvious clerical errors were identified during the canvass and there was one absentee ballot that was rejected and not counted due to incomplete affidavit.
