

The Adams County Board of Supervisors met on Monday, November 22, 2021 at 9:00 am with the following members present: Bobbi Maynes, Leland Shipley, and Scott Akin. Absent were Doug Birt and Merlin Dixon. The meeting was called to order by Chairperson Maynes and the Pledge of Allegiance was recited. Akin moved, seconded by Shipley to approve today's agenda along with the minutes from November 15, 2021. All supervisors voted aye. Motion carried.

Engineer Travis Malone updated the board on the Secondary Roads Department. The Hull Street. Bridge is anticipated to be closed starting December 15 to start the bridge replacement project. Shipley moved, Akin seconded to approve Utility Permit 21-13 for Southwest Iowa REC on Adams Taylor by Denver Ave. All supervisors voted aye. Motion carried.

Discussion was held regarding the Court House renovations. The board is expecting a final survey from the architects any day now.

Discussion was held on the voted Ambulance Levy for EMS services. Akin asked if we should put that before the voters to see if they would rather have a levy for EMS services or fund EMS services out of the regular budget. EMA Director Bill Lyddon asked how funds would be divided up since there are multiple Ambulance/Rescue services within the County. The board is going to research the issue further.
