

Board Minutes**Corning, Iowa****January 24, 2022**

The Adams County Board of Supervisors met on Monday, January 24, 2022 at 9:00 am with the following members present: Bobbi Maynes, Leland Shipley, Merlin Dixon, Doug Birt and Scott Akin. The meeting was called to order by Chairperson Birt and the Pledge of Allegiance was recited. Akin moved, seconded by Maynes to approve the agenda for the day and to approve the minutes of the January 18th meeting. All supervisors voted aye. Motion carried. There were no public comments.

Akin moved, seconded by Dixon to approve purchasing the half-interest of Taylor County's Secondary Roads Department EZ Liner Pavement Marking Machine for \$14,000. All supervisors voted aye. Motion carried.

Shipley moved, seconded by Akin to approve the Secondary Roads Budget to be submitted to the DOT in the amount of \$4,222,451. All supervisors voted aye. Motion carried. It is the same budget that was approved last week at the county level.

County Engineer Malone updated the board on plans for projects that are currently underway and will need attention during the transition period to a new county engineer.

Akin moved, seconded by Dixon to approve the claims as presented. All supervisors voted aye. Motion carried.

Dixon moved, seconded by Maynes to accept the recommendation from the Temporary Redistricting Committee and approve the Supervisor Districts as prepared by the Legislative Services Agency. All supervisors voted aye. Motion carried.

Maynes moved, seconded by Akin to approve a Precinct Election Official pay increase effective as of today to \$200 for precinct chairs and \$175 for precinct officials. Those working less than a full day will be paid a percentage of time worked. All supervisors voted aye. Motion carried.

No action was taken on posting the County Engineer position available.

Budgets were presented Prescott Library, Villisca Library, and SICOG.

Scott Stevenson, from DA Davidson presented to the board information on bonding for the renovation project. Two scenarios were presented with structuring the debt with the conservation bonds debt as it would level out the impact on taxpayers. He presented examples of the tax implications for residents. The board will need to decide whether they would like to lock in the financing piece first or get bids on the project and then proceed with the financing. The board is wanting to have informational meetings for the public and he said that he would be available to attend to assist in explaining the bonding aspect and the impact it would have on residents.

Department Head Reports: IT- email is now working and Secondary Roads has phones again, Conservation – staff will be attending meetings this week, Auditor – Special Election for Creston School will be March 1.

Maynes moved, seconded by Akin to adjourn the meeting at 11:29 AM. All supervisors voted aye. Motion carried.
