The Adams County Board of Supervisors met on Monday, June 20, 2022 at 9:00 AM with the following members present: Bobbi Maynes, Leland Shipley, Merlin Dixon, Scott Akin, and Doug Birt. The meeting was called to order by Chairperson Birt and the Pledge of Allegiance was recited.
