

## Board Minutes October 31, 2022

The Adams County Board of Supervisors met on Monday, October 31, 2022, at 9:00 AM with the following members present: Doug Birt, Bobbi Maynes, Leland Shipley, Scott Akin, and Merlin Dixon. The meeting was called to order by Chairperson Birt and the Pledge of Allegiance was recited. Akin moved, seconded by Maynes to approve the agenda for today's meeting along with the minutes from October 24 and October 26. All supervisors voted aye. Motion carried.

During Public Comments, Mayor of Corning Jan Leonard shared that the Drop-It recycling system is almost ready to be installed in Corning.

Akin moved, seconded by Maynes to approve an hourly wage increase for the Assistant to the Engineer to \$31/hour. All supervisors voted aye. Motion carried.

Shipley moved, seconded by Dixon to approve the 28E Agreement between Adams County and the Iowa DOT for issuance of Driver's Licenses. All supervisors voted aye. Motion carried.

Shipley moved, seconded by Maynes approved contributing \$600 to the Soil Compaction Study. The funds will come from the Board of Supervisors line item of the budget. All supervisors voted aye. Motion carried.

Department Head reports were presented as follows: Secondary Roads – Only have one semi that is working at this time, the work is finished on Birch and H54 and work continues on the Carbon road. The crew is still shouldering and with warm weather hopefully can paint lines before the weather turns cold. Putting up new doors on some of the shops. The meeting scheduled with the Hull Street project did not progress and the contractor did not show up. Sheriff – Have interviews this week, active shooter drill at school this week, still working on vehicle from Kentucky. Treasurer – 97.85% of taxes have been paid, 330 entities will be getting delinquent notices this week. Conservation – All water shut down except for full-service sites. All the cabins and cottages were full this past weekend. Lots of hunters on the public grounds. IT- Lots of security patches and updates installed and to be installed to keep system working and secure. Auditor – Absentee voting in progress, open this Saturday from 9-5 for voting purposes, Election Day is next Tuesday.
