

**Board Minutes March 20, 2023**

The Adams County Board of Supervisors met on Monday, March 20, 2023, at 9:00 AM with the following members present: Leland Shipley, Chris Standley, Bobbi Maynes Tony Hardisty, and Scott Akin. The meeting was called to order by Chairperson Shipley and the Pledge of Allegiance was recited. Akin moved, seconded by Standley to approve the minutes of March 14, 2023, meeting and to approve the agenda as presented. All supervisors voted aye. Motion carried.

Standley moved, seconded by Maynes to approve Bridge Replacement Agreement: 150th Street over the E. Nodaway River, Bridge Colony 19, FHWA No. 060500, HGM Proposal No. 000723-028. All supervisors voted aye. Motion carried.

Akin moved, seconded by Hardisty to approve Utility Permit #23-04 for SIRWA on 183<sup>rd</sup> Rd. All supervisors voted aye. Motion carried.

Tony Mullen along with other farmers shared concerns with the board regarding the current policy and what they would like to see changed. Akin moved, seconded by Maynes to table the Driveway Policy so they can gather more information. All supervisors voted aye. Motion carried.

The board discussed with Engineer Bechtold amending the current TIF plan to include more projects.

Jayne Templeton shared with the board the health insurance rate was increasing by 3.72%. Hardisty moved, seconded by Standley to approve the health insurance plan. All supervisors voted aye. Motion carried.

Maynes moved, seconded by Standley to approve Liquor License application for The Legacy Venue LLC at 3148 170<sup>th</sup> St. All supervisors voted aye. Motion carried.

Discussions on the FY 23-24 budget and Court House Renovations were held.

Department Head Reports: Secondary Roads-RR Crossing issues keep arising. Sheriff – The car’s motor wasn’t the issue so that is a relief. The new deputy has started this week. Auditor – Budget has been submitted to the DOM. Finishing up the special election duties. IT – Sheriff server has been installed and configured. It should be up and fully functioning by next week. Looking at a new server on next year’s budget for the Court House as it’s reaching end of life. Conservation – Getting Spring Maintenance items done and working on fixing leaks around the park. Marti will graduate from the Academy on April 23<sup>rd</sup>. Treasurer – First half of taxes are 99% received with around \$21,000 left to collect. Second half of taxes are due the end of the month and we are at 58% collected with 2.6 million left to collect.

During Public Comments Matt Olive, Marcia Allen, Juli Cooper, and Lynn Irr spoke out against wind turbines. The group again asked for a moratorium until the board can review the ordinances.

Committee and Meeting reports were presented as follows: Maynes – United Fiber, Maryville, Mar 17; Standley – DECAT, Creston, Mar 17; Shipley – Main St EV, Corning, Mar 15; and Akin- United Fiber, Maryville, Mar 17.

Maynes moved, seconded by Akin to adjourn the meeting at 11:45 am. All supervisors voted aye. Motion carried.
