## RESOLUTION TO DESTROY CERTAIN ELECTION RECORDS IN THE COUNTY AUDITOR'S OFFICE

WHEREAS, Section 50.19 of the Code of Iowa states the commissioner of elections may destroy material pertaining to elections that are not required to be kept as permanent records; and

WHEREAS, the County Auditor's Office has identified records appropriately for destruction and has inventoried said records as follows:

- General Election 2020
- City/School Election 2021
- Special Election Creston School, March 1, 2022

• Special Election – Adams County and Creston School, September 13, 2022

THEREFORE, BE IT RESOLVED by the Adams County Board of Supervisors that the County Auditor destroy said records in an appropriate and secure manner according to Section 50.19 of the Code of Iowa.

All supervisors voted aye. Motion carried. Attested by the Auditor, Rebecca Bissell. The original resolution is on file in the Auditor's Office.

Akin moved, seconded by Standley to approve the Treasurer Quarterly Investment Report presented by Treasurer Schafer. All supervisors voted aye. Motion carried.

Discussion on changes to the Ordinances for Wind Energy was held. The board is looking to add a Road Use Agreement, potential decommissioning items, potential change of setback distance, potential capping of quantity of wind turbines, potential addition of noise restrictions, potential items regarding blades such as color and finish to the blades, and potential lighting requirements.

Secondary Roads: Chairman Shipley spoke with Mike Steenhoek with The Soy Transportation Coalition about potentially getting some grant money for soft costs on bridge repairs or replacements if they use one of the designated innovative designs. 28E Agreements have been sent and presented to Corning and Carbon for City bridge projects that Secondary Roads is helping with. Bechtold is meeting with Prescott tomorrow night for their city bridge project. Purple Wave came last week, and the auction deadline is May 2<sup>nd</sup>. The mechanic's truck is here and being put to use.

Rand Fisher, the Iowa State Director of Center for Infrastructure & Economic Development, presented the services the Center for Infrastructure & Economic Development can provide to the board. They can review the proposed ordinance changes and give feedback at no cost to the county. Maynes moved, seconded by Akin to approve engaging in the services of the Center for Infrastructure & Economic Development. All supervisors voted aye. Motion carried.

Jeanne Jackson read a letter from Union County resident Hannah Miller speaking about her son who has seizures, and she feels those are due to the lights/flickering of wind turbines. Dan Dahl spoke against wind turbines and is asking for a higher setback. Steve and Jeanine Bennett weren't present to speak during their allotted time on the agenda. Diane Jacobs read a letter from Jim Freeland who doesn't want wind turbines in Adams County.

Department Head Reports: Treasurer – \$200,000 left to collect in taxes. IT – Homeland Security updates that affected the county have been patched. It took about two half-days each to get everything corrected. Conservation – They have started turning on water to the restrooms and fish cleaning stations. They expect to have all restrooms and water facilities open and all of the docks in the water by the end of next week. Please remember free camping is being offered this coming weekend, April 14th and 15<sup>th</sup>. Several individuals from the DNR Parks Department came to tour the shop/office facility last week. They were very impressed with our facility and the budget we accomplished it with. We spent \$313,000 on the shop/office building. In comparison, the State built a new shop office at Viking Lake a couple of years ago. Their shop and Office are all smaller and they agreed less functional than ours, and they spent just shy of \$1 Million on that facility. Conservation continues to strive to make the best use of the funds that they are given to work with and are very thankful and grateful for the continued support they have from each one of the board members. Auditor – Bissell will be gone Wednesday and Thursday for ICAP Board of Directors meetings. VA – Slowly working towards Kevin training a new hire to replace him, due to him wanting to retire by end of fiscal year.

Public comments were presented by the following: Juli Cooper and Lynn Irr spoke against the turbines.

Committee and Meeting reports were presented as follows: Standley – RC&D, Creston, Apr 6.

Akin moved, seconded by Maynes to adjourn the meeting at 11:20 am. All supervisors voted aye. Motion carried.
