Maynes moved, seconded by Akin to approve the Contract Renewal with Cost Advisory Services, Inc. for \$4,500. All supervisors voted aye. Motion carried.

Maynes moved, seconded by Standley to approve the handbook change for 5.13 Seatbelt Restraint Policy. All supervisors voted aye. Motion carried.

Don Vogel spoke in favor of wind turbines. He was raised in Lincoln Township and has two wind turbines still on the land he owns there but has moved to town. He worries about the future of our energy use and being able to keep up with fossil fuels.

Department Head Reports: Secondary Roads – The southeast and the northwest rural areas of the county have been completed with contract rock. 150<sup>th</sup> Street west of Uban Ave will be closed from 10:00-4:00 today to do soil borings. Engineer attended NACE last week, will be having motor grader training the end of May. A new base stabilization product is being applied in some areas as a test, working on 28E agreements with the City of Carbon and the City of Corning, Updated the department's time sheets, Karen will be gone for a couple

of days to attend training. Auditor – Working on the budget amendment and certifying next fiscal year's budgets. Treasurer – Scanner is now set up and document locator is working. Delinquent tax notices go out on May 1. \$165,000 in taxes are still due. Sheriff – Vehicles are in, and he hopes to have both up and running in a couple of months. The new officer will be leaving to attend the academy soon.

Scott hasn't heard back from DCI concerning courthouse renovations.

Public comments were presented by the following: Betsy and Denny Reichardt submitted a letter in support of wind turbines. Jeanne Jackson presented 17 more signatures asking for the Moratorium and requested to be involved in the writing of the ordinances. Saundra Leininger invited the Board to a presentation on Sunday April 30 at 2:00 pm at the Opera House to meet Zachary Taylor Widener (portrayed by Ben Mullen). in celebration of Preservation Month. Juli Cooper and Diane Jacobs both expressed their concerns about wind turbines. Gary Badgett offers his support to the Board.

Committee and Meeting reports were presented as follows: Akin- ACEDC, Corning, April 20, Southern Hills, Corning, April 21; Standley – DECAT, Creston, April 21; Shipley – Main Street, Corning, April 17, Main Street EV, Adams Community Foundation, Corning, April 19, Main Street Annual Awards, Des Moines, April 21.

The board will be holding a work session on Thursday, April 27 at 9 AM to review ordinances.

Maynes moved, seconded by Standley to adjourn the meeting at 11:10 am. All supervisors voted aye. Motion carried.
