Board Minutes May 8, 2023

The Adams County Board of Supervisors met on Monday, May 8, 2023, at 9:00 AM with the following members present: Leland Shipley, Chris Standley, Bobbi Maynes, Tony Hardisty, and Scott Akin. The meeting was called to order by Chairperson Shipley and the Pledge of Allegiance was recited. Standley moved, seconded by Maynes to approve the minutes of May 1, 2023, meeting and the May 5, 2023 work session and to also approve the agenda as presented. All supervisors voted aye. Motion carried.

There was no additional information regarding fuel bids for Secondary Roads so the action item was tabled.

Maynes moved, seconded by Standley to approve Utility Permit 23-07 for Farmers Mutual Telephone Company on Chestnut Avenue. All supervisors voted aye. Motion carried.

Hardisty moved, seconded by Maynes to approve Resolution 2023-18 Driveway Policy.

Resolution 2023-18

Approval of Adams County Entrance Policy

WHEREAS, The Adams County Entrance Policy, dated May 8, 2023, establishes the requirements for design and construction of driveways and driveway extensions within Adams County,

ADAMS COUNTY ENTRANCE POLICY AMENDED 2023

1) The County will require a permit per entrance for each new or widened entrance to the Secondary Road System. The location of the entrance will be at the owner's request, adequate the sight distance (per AASHTO's Policy on Geometric Design of Highways and Streets), and other related factors are approved by the Engineer.)

2) Slope from the edge of entrance to the ditch flow line will be as follows:

Paved Road -- Dry Fill or culvert 6H:1V

Gravel Road -- Dry Fill or culvert 3H:1V

The minimum width of entrances is 20 feet. The County will designate the minimum length and diameter of the pipe to achieve efficient drainage and width of entrance. No entrance pipe shall be less than 18 inches in diameter unless specified by the Engineer.

3) The owner shall have the entrance or extension installed by private contractors or with their own equipment. All work performed will be subject to the approval of the County Engineer or the designated representative.

4) Costs of all new installation(s), extension(s) and maintenance will be the responsibility of the property owner. The County will maintain stockpiles of new 1811 diameter pipe for purchase, with a minimum length to purchase of 10 feet.

5) A new driveway culvert for new residential house construction may be scheduled and installed by the County. New driveway entrance culverts will be installed when the county crew(s) are repairing culverts in the vicinity of the property. The owner will be responsible for the purchase of the culvert. The request and schedule will be at the discretion of the County Engineer.

6) All culverts placed in entrances shall be of new materials. Culverts shall be of annular, corrugated, riveted construction, black HDPE plastic, or reinforced concrete pipe. Pipe shall meet Iowa DOT's standards for wall thickness.

7) Extensions to existing entrances will only be allowed when the existing culvert is in good condition.

8) County will not provide or restore any type of surfacing on entrances. Driveway surfacing, such as granular surfacing or pavement, shall be the responsibility of the adjacent landowner.

9) The slope of the entrance will be a minimum of six inches (6") lower than the edge of the roadway edge. The County maintenance personnel are allowed to maintain an entrance to prevent water from damaging the roadway surface. The County will maintain the entrance driveways for failed culverts. The County will maintain the culvert and the adjacent landowner will have the option to replace the culvert at owner's cost. The County will provide the work if in the area at the engineer's discretion. The culverts to occupied residences will be removed and replaced at County's expense.

10) During construction and/or installation, all necessary and proper barricade, signage, etc., as per the Manual on Uniform Traffic Control Devices, shall be always maintained to protect workers, property owners, and the traveling public from accidents due to operation of the applicant. The applicant will be required to furnish any dirt necessary for the construction of driveways and field entrances. Any materials from inside the ROW shall be with the approval of the County Engineer or the designee.

11) The County Engineer or the designee will verify the work upon completion and notification by applicant and/or installer. When the work is found to be non-compliant with this policy, a written notice will be issued. The applicant will have 30 calendar days from receipt of notice to bring the entrance into compliance.

12) The County Engineer or the designated representative is hereby named the permit officer to administer the terms of this policy. Administrative decisions of pipe size and length, sight distance and other safety factors will be final. Other appeals of administrative decisions may be appealed to the Board of Supervisors in writing at any time or orally at a regularly scheduled Board meeting. Board decisions shall be entered into the minutes.

13) The County shall be indemnified and saved harmless from any changes resulting from the applicant's operations.

14) This policy voids and takes precedence over any previous entrance policies in the County.

THEREFORE, BE IT RESOLVED, That the Adams County Entrance Policy is adopted by the Adams County Board of Supervisors at Corning, Iowa on the 8th day of May 2023. All supervisors voted aye. Motion carried. Attested by the County Auditor Bissell. The original resolution is on file in the Auditor's Office.

RESOLUTION SETTING DATES OF A CONSULTATION AND A PUBLIC HEARING ON A PROPOSED AMENDMENT NO. 1 TO THE SOUTHERN HILLS WIND FARM URBAN RENEWAL PLAN IN ADAMS COUNTY, STATE OF IOWA

WHEREAS, by Resolution No. 2022-35, adopted October 10, 2022, this Board found and determined that certain areas located within the County are eligible and should be designated as an urban renewal area under Iowa law, and approved and adopted the Southern Hills Wind Farm Urban Renewal Plan (the "Plan" or "Urban Renewal Plan") for the Southern Hills Wind Farm Urban Renewal Area (the "Area" or "Urban Renewal Area") described therein, which Plan is on file in the office of the Recorder of Adams County; and

WHEREAS, County staff has caused there to be prepared a form of Amendment No. 1 to the Plan ("Amendment No. 1" or "Amendment"), a copy of which has been placed on file for public inspection in the office of the County Auditor and which is incorporated herein by reference, the purpose of which is to update the description of previously approved urban renewal projects and to identify new urban renewal projects to be undertaken within the Urban Renewal Area; and

WHEREAS, it is desirable that the area be redeveloped as part of the overall redevelopment covered by the Plan, as amended; and

WHEREAS, this proposed Amendment No. 1 adds no new land to the Urban Renewal Area; and

WHEREAS, the Iowa statutes require the Board of Supervisors to notify all affected taxing entities of the consideration being given to the proposed Amendment No. 1 and to hold a consultation with such taxing entities with respect thereto, and further provides that the designated representative of each affected taxing entity may attend the consultation and make written recommendations for modifications to the proposed division of revenue included as a part thereof, to which the County shall submit written responses as provided in Section 403.5, Code of Iowa, as amended; and

WHEREAS, the Iowa statutes further require the Board of Supervisors to hold a public hearing on the proposed Amendment No. 1 subsequent to notice thereof by publication in a newspaper having general circulation within the County, which notice shall describe the time, date, place and purpose of the hearing, shall generally identify the urban renewal area covered by the Amendment and shall outline the general scope of the urban renewal project under consideration, with a copy of the notice also being mailed to each affected taxing entity.

NOW THEREFORE, BE IT RESOLVED, BY THE BOARD OF SUPERVISORS OF ADAMS COUNTY, STATE OF IOWA:

Section 1. That the consultation on the proposed Amendment No. 1 required by Section 403.5(2), Code of Iowa, as amended, shall be held on May 16, 2023, in the Board of Supervisors Room, Adams County Courthouse, 500 9th Street, Corning, Iowa, at 10:00 A.M., and Becky Bissell, County Auditor, or her delegate, is hereby appointed to serve as the designated representative of the County for purposes of conducting the consultation, receiving any recommendations that may be made with respect thereto and responding to the same in accordance with Section 403 .5(2), Code of Iowa.

Section 2. That the County Auditor is authorized and directed to cause a notice of such consultation to be sent by regular mail to all affected taxing entities, as defined in Section 403.17(1), Code of Iowa, along with a copy of this Resolution and the proposed Amendment No. 1, the notice to be in substantially the following form:

Section 3. That a public hearing shall be held on the proposed Amendment No. 1 before the Board of Supervisors at its meeting which commences at 9:00 AM. on June 5, 2023, in the Board of Supervisors Room, Adams County Courthouse, 500 9th Street, Corning, Iowa.

Section 4. That the County Auditor is authorized and directed to publish notice of this public hearing in the Adams County Free Press, once on a date not less than four (4) nor more than twenty (20) days before the date of the public hearing, and to mail a copy of the notice by ordinary mail to each affected taxing entity, such notice in each case to be in substantially the following form:

Adams County, State of Iowa is the local public agency which, if such Amendment is approved, shall undertake the urban renewal activities described in such Amendment.

The general scope of the urban renewal activities under consideration in the Amendment is to promote the growth and retention of qualified industries and businesses in the Urban Renewal Area through various public purpose and special financing activities outlined in the Amendment. To accomplish the objectives of the Amendment, and to encourage the further economic development of the Urban Renewal Area, the Amendment provides that such special financing activities may include, but not be limited to, the making of loans or grants of public funds to private entities under Chapter 15A, Code of Iowa. The County also may reimburse or directly undertake the installation, construction and reconstruction of substantial public improvements, including, but not limited to, street, water, sanitary sewer, storm sewer or other public improvements. The County also may acquire and make land available for development or redevelopment by private enterprise as authorized by law. The Amendment provides that the County may issue bonds or use available funds for purposes allowed by the Plan and that tax increment reimbursement of the costs of urban renewal projects may be sought if and to the extent incurred by the County. The Amendment initially proposes specific public infrastructure or site improvements to be undertaken by the County, and provides that the Amendment may be amended from time to time.

The proposed Amendment No. I would update the description of previously approved urban renewal projects and identify new urban renewal projects to be undertaken within the Urban Renewal Area. The proposed Amendment adds no new land to the Urban Renewal Area.

Other provisions of the Plan not affected by the Amendment would remain in full force and effect. Any person or organization desiring to be heard shall be afforded an opportunity to be heard at such hearing.

INTRODUCTION AND HISTORY

The Southern Hills Wind Farm Urban Renewal Plan ("Plan" or "Urban Renewal Plan") for the Southern Hills Wind Farm Urban Renewal Area ("Area" or "Urban Renewal Area"), adopted in October 2022, is being amended by this Amendment No. I ("Amendment" or "Amendment No. I") to update the description of previously approved urban renewal projects and to identify new urban renewal projects to be undertaken within the Urban Renewal Area.

No land is being added to or removed from the Urban Renewal Area by this Amendment. Accordingly, the previously established "base value" or "base valuation" of the Urban Renewal Area (if any) will remain unchanged by this Amendment.

Except as modified by this Amendment, the provisions of the original Urban Renewal Plan are hereby ratified, confirmed, and approved and shall remain in full force and effect as provided herein. In case of any conflict or uncertainty, the terms of this Amendment shall control. Any subsection of the Plan not mentioned in this Amendment shall continue to apply to the Plan.

AREA DESIGNATION

The Urban Renewal Area continues to be an economic development area that is appropriate for the promotion of economic development (including commercial and industrial development).

DEVELOPMENT PLAN

Adams County has a general plan for the physical development of the County as a whole, outlined in the <u>Comprehensive Plan - Corning and Adams County, IA</u>, adopted in 1966. The goals and objectives identified in this Plan, and the urban renewal projects described herein, are in conformance with the goals and land use policies identified in the <u>Comprehensive Plan - Corning and Adams County, IA</u>.

This Amendment does not in any way replace or modify the County's current land use planning or zoning regulation process.

The need for improved traffic, public transportation, public utilities, recreational and community facilities, or other public improvements within the Urban Renewal Area is set forth in this Amendment. As the Area develops, the need for public infrastructure extensions and upgrades will be evaluated and planned for by the County.

UPDATE TO PREVIOUSLY PPROVED URBAN RENEWAL PROJECTS

The Urban Renewal Plan identified several urban renewal projects. Except as expressly noted below, those projects remain unaltered by this Amendment and are hereby confirmed. With the adoption of this Amendment No. 1, the County is updating the description of the following urban renewal project that was originally approved in the Urban Renewal Plan.

1. Public Improvements:

A. Bridge ID - Prescott 13: In the Urban Renewal Plan, the County authorized roadway improvements for Bridge ID - Prescott 13 as an urban renewal project. The original Plan authorized \$882,600 for this project to be reimbursed through TIF. The expected costs of this project have increased. Accordingly,

with the adoption of this Amendment, the County is authorizing an additional \$152,400 for this project's costs, for total project costs not to exceed \$1,035,000 to be reimburse through TIF.

This Amendment No. I will become effective upon its adoption by the Board of Supervisors and will remain in effect until it is repealed by the Board of Supervisors. Notwithstanding anything to the contrary in the Plan or any prior resolution or document, the Plan, as amended, shall remain in effect until terminated by the Board of Supervisors.

The use of incremental property tax revenues, or the "division of revenue," as those words are used in Chapter 403 of the Code of Iowa, will be consistent with Chapter 403 of the Iowa Code. Nothing in this Amendment shall alter the duration of the division of revenue as previously explained in the Plan.

REPEALER AND SEVERABILITY CLAUSE

Any parts of the previous Plan in conflict with this Amendment are hereby repealed. If any part of this Amendment or the Plan is determined to be invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the validity of the Amendment or the Plan as a whole, or any part of the Amendment or the Plan not determined to be invalid or unconstitutional.

Jeanne Jackson wants a 1-mile setback for non-participating landowners. She has concerns the big companies don't have Adams County's residents best interest in mind.

Juli Cooper read her letter from March that she had previously submitted to the Supervisors. She is concerned about non-participating landowners having to give up their rights.

Department Head Reports: Auditor – Working on the budget amendment and certifying budgets. Secondary Roads – Foreman's truck transmission is out with only 4000 miles on it, it should be under warranty. One of the maintainers seems to continue to have several issues. The maintainer is not scheduled to be traded in until 2024, but this may have to be moved up. Treasurer – \$117,000 on 310 parcels are still left to collect which seems high. Holly will be gone this week for Treasurer's training. Recorder – Have received books back and have 109 more to be scanned. Have 19 applications for opening in Recorder's Office and the application window closes this week. Hoping to interview the top five people.

Nothing to report concerning courthouse renovations.

Public comments were presented by the following: Marcia Allen wanted to point out that Tammy Baier came of her own accord with no interest other than sharing her experiences and she hopes that the board appreciates that. Diane Jacobs wanted to know if someone wants to build in the setback area after the turbines are built can they build there or does that not allow them future use of their property?
