Discussion and possible action on the Adams County Comprehensive Plan Proposal from SICOG was tabled.

Hardisty moved, seconded by Standley to approve the Liquor License App – 182943 Bobbers Down. All supervisors voted aye. Motion carried.

Department Heads reports were as follows: Secondary Roads - Preconstruction meeting on Jasper on Ginkgo Ave. north of Hwy 34 is scheduled for tomorrow. Colony 19 has a cost estimate of \$1,400,000. DOT has gotten involved with the Nodaway RR crossing, so this project should be starting in a couple weeks. Talking to the RR about the Prescott RR crossing. Colony 10 & Douglas 2 need some intense repairs to their grading. Started a new program in the office to track citizens' concerns. Reached out to a few consultants about doing an RFP to update the County's Comprehensive Plan. Updating the Road Use Plan. Discussed wanting to purchase compactor for base stabilization projects and using ARPA funds for it. Northeast area contract rock has been completed and now working on their last contract area of the Southwest starting today. Only have 4 motor graders running at this time as they are waiting on parts for the other blade. Karl will be gone Wednesday for Street and Roads Conference. Auditor – Attending the ICAP Board of Directors meeting and received great information on the struggles with insurance right now. Have a Solutions meeting on Thursday for Fiscal Year End/ Cash Balancing training. Started working on taxes, but still needing information from the Dept of Management. Next week will be the Auditor Summer School. Sheriff - still waiting for the new vehicles to be upfitted. There is very little equipment that can be reused, and the cost has increased significantly pushing near \$20,000. Have an opening for a dispatcher. IT – Cloudstrike has been installed on all computers in the Court House which sprung an alert on Saturday, so needed to come in to work to get that remedied. Will be attending IT conference this week in Des Moines. Recorders - Gone this week Wed-Friday for Recorders Summer School. Received scanned books back and sent out 24 more books. DOT increased some fees the County can keep. Treasurer – Tax Sale is set for Monday June 19. Friday June 16th is the last day you can pay your taxes in the Treasurer's office. Currently there are \$39,862 left to be paid and 117 parcels.

Jeanne Jackson, Juli Cooper, and Marcia Allen shared concerns with wind turbines.

Public Comments: Matt Olive spoke concerning wind turbines.

Committee and Meeting Reports were presented as follows: Maynes – United Fiber, Via Zoom, June 5; Akin – United Fiber, Via Zoom, June 5, SICOG, Creston, June 6; and Shipley – Adams Community Foundation, Corning, June 6.
