Assessor Ben Mullen explained how solar farms are valued and taxed. If the energy is sold on the grid, then it is centrally assessed. If it is being sold directly to customers, then it is locally assessed. There are a lot of gray areas that Mullen is seeking answers from the State regarding this issue.

There was no action taken on remote access to the county's network to work from home.

Maynes moved, seconded by Hardisty to appoint Lynn Brandt to the Zoning Commission. Chris Standley would like to see someone appointed who is more neutral with current wind turbine topics. Maynes stated there are several issues besides wind turbines that the Zoning commission deals with and she wants someone who will show up to the meetings and do the job before them. Hardisty pointed out that in January the board had thought Brandt would do a good job but the appointment was postponed and he feels she would still be a good person for the position. Ayes: Maynes, Hardisty, Akin. Nays: Standley. Motion carried.

Standley moved, seconded by Hardisty to refer to the Zoning Commission development of zoning ordinances for utility-scale wind energy generation facilities and for utility-scale and personal agricultural use solar energy generation facilities. Standley, Hardisty, Akin voted aye. Maynes abstained. Motion carried.

Department Head Reports: Secondary Roads – Base Stabilization demo was completed last week. Motor grader training went well. Lots of tube replacements will be coming up including one on Filbert Ave. Tractor should be coming in soon. Hauling spot rock to problem areas. Recorder – Training is going well with new employee, getting more books back shortly. IT – Phishing emails from Russia are being dealt with, new server is up and running. Sheriff – Jail inspection went well. Having issues getting new vehicles upfitted, there is a vehicle ready to go that will need a decision. Auditor – Working on taxes. Conservation – Storm damage has been cleaned up. The program "Scales and Tails" was well attended and there will be a kayak outing this week.

Public Comments opposing wind turbines were presented by: Marcia Allen and Diane Jacobs. Jeanne Jackson reiterated ordinance recommendations. Marvis Northup had questions on whether any studies had been done and if non-participating landowners were paid. Juli Cooper discussed Good Neighbor Agreements and would like to see setbacks from property lines.

Public Comments in favor of wind turbines were presented by: Mike Mullen related that he has spoken with some of the people who signed the petition and questioned whether they were receiving all of the facts on what they were signing. He is asking to keep the ordinances as they are currently.

The next meeting will be held on Monday July 24th.

Committee and Meeting reports were presented as follows: Akin-Southern Hills Mental Health, Corning, July 21; and Maynes – United Fiber-Maryville, Zoom, July 18.

Standley moved, seconded by Hardisty to adjourn the meeting at 10:30 AM. All supervisors voted aye. Motion carried.
