Marketing Travel Iowa has produced quite a few tours. There is going to be a Travel Iowa Market Place Conference on November 2. Housing and broadband access are two areas of major work of ACEDC. On October 4 there will be a SWV Career Fair to educate students on local opportunities for work, careers, and businesses. MainStreet Corning is working on grants for housing and Sally's Alley. A new silver cord program is being instituted for graduates who have volunteer hours in the community. Working on generating more traffic on Facebook. On October 12 Corning will have their MainStreet Accreditation visit.
