

Board Minutes January 16, 2024

The Adams County Board of Supervisors met on Tuesday, January 16, 2024, at 9:00 AM with the following members present: Tony Hardisty, Scott Akin, Chris Standley, Bobbi Maynes, and Leland Shipley. The meeting was called to order by Chairperson Akin. The Pledge of Allegiance was recited. Maynes moved seconded by Hardisty to approve the agenda along with the minutes of January 8 regular meeting. All supervisors voted aye. Motion carried.

Secondary Roads update as follows: The front-end loader is having issues and not working at this time. The snow crews were out for 13 hours each day during the recent storm and they have been doing a good job. Old Highway 34 is down to one lane and are renting a blower to clean out some specific areas. Did have one of the trucks go in a ditch and had to get a tow truck to pull it out as well as had issues with fuel on Sunday. Safety training has been rescheduled. Kick off last Thursday of Comprehensive Safety Plan. Colony 19 needs temporary easements. Logan is getting his DOT certifications this week. The concrete testing equipment is being calibrated. Sending out RFP's for 2 bridges. Have not gotten reimbursements from railroad for crossing in Nodaway. Working on railroad agreements with crossings. Hungry Canyon has been rescheduled to February 15.

Maynes moved, seconded by Standley to approve offer for Jasper 1 (City Bridge Funding). All supervisors voted aye. Motion carried.

Shipley moved, seconded by Maynes to approve Recorder's Quarterly Report. All supervisors voted aye. Motion carried.

Standley moved, seconded by Shipley to approve the Liquor Application 174474 for The Legacy Venue, LLC. All supervisors voted aye. Motion carried.

Shipley moved, seconded by Hardisty to accept the resignation of Nodaway Township Clerk Bette Agnew with thanks for her service. All supervisors voted aye. Motion carried.

Discussion and possible appointment of Nodaway Township Clerk was tabled.

Maynes moved, seconded by Shipley to appoint Jeanne Birt to the Human Services Board for a term of one year. All supervisors voted aye. Motion carried.

Marvis Northup discussed with the board the confusion surrounding the Comprehensive Plan process.

Discussion and action on approval of Comprehensive Plan was tabled until next week.

Public Health presented its budget request and also gave an update on the department.

Department Head reports: IT – working on implementation of panic buttons, also comparing Access and FMTC phone system option.

Committee and Meeting Reports: Akin – Emergency Management, Jan 10, Corning, USDA siting, Jan 12, ZOOM; Shipley – Loss Control, Jan 16, Corning, Adams Community Foundation, Jan 10, Corning.
