Maynes moved, seconded Shipley to approve 28E Agreement between Adams County and Heart of Iowa Region. All supervisors voted aye. Motion carried.

Department Head Reports: Secondary Roads – Have hauled 3500 ton of rock, working on ditch clearing near Cass/Adams line on Holly, semi should be back this week, had Hungry Canyons meeting on Friday, Logan passed Erosion Control DOT certification, a new starter was installed on #60, doing some cold patching today, putting together a plan for base stabilization for Juniper Avenue. Waiting on some signs, Mechanics truck has been delayed until June, have reached out to Agrivision to get options for leased tractor. Conservation – Water leak is fixed, concrete will be poured when weather allows, Triatholon website is up, going to look at kayak launch, attended a training. IT – Panic buttons are to be installed next week, telephones all in. Treasurer – 55% of second half taxes are paid, short about \$3 million, online payments have seen an uptick, tax sale in June. Auditor - Updating budgets for salaries and insurance.
