A total of 230 votes were cast in Adams County at the Primary Election on June 4, 2024. Candidates nominated by the Republican Party were: County Supervisor 2 – Tony Hardisty, County Supervisor 5 – Christopher Standley, County Auditor – Becky Bissell and County Sheriff – Alan Johannes. There were no candidates nominated by the Democratic Party nor the Libertarian Party for County Supervisor 2, County Supervisor 5, County Auditor, and County Sheriff. Standley moved, seconded by Hardisty to accept the results of the canvass. All supervisors voted aye. Motion carried.

Department head reports: Auditor – Finishing up the Primary Election, working on budgets and reports to the state. Preparing for ISACA Summer Conference to be held the last week of June. IT – Have created a 3rd domain controller at a cost of approximately \$150/year to help with rebuilding the network should that every be an issue. Attending the annual IT conference next week. Sheriff – Have lost SRO as he went back to Cass County, trying to get another deputy hired, golf fundraiser for the dog this weekend. New Vehicle is getting prepped at Karl's Chevrolet.
