

Board Minutes July 1, 2024

The Adams County Board of Supervisors met on Monday, July 1, 2024, at 9:00 AM in the Adams County Court Room with the following members present: Tony Hardisty, Leland Shipley, Bobbi Maynes, Chris Standley, and Scott Akin. The meeting was called to order by Chairperson Akin at 9:00 AM. The Pledge of Allegiance was recited. Hardisty moved, seconded by Maynes to approve the agenda and the minutes of June 24th meeting. All supervisors voted aye. Motion carried.

Maynes moved, seconded by Standley to appoint Pat Getter to a 6-year term on the Civil Service Commission. All supervisors voted aye. Motion carried.

Discussion was held on the Adams County Ordinances to consider changes to the Wind and Solar Ordinances. No action was taken.

At 10:48 AM, Maynes moved, Hardisty seconded to go into closed session pursuant to Iowa Code 21.5(1)(i) to review employee performance. All supervisors voted aye; motion carried. The Board went into closed session. Maynes moved, Standley seconded to come out of closed session at 11:18 am. All supervisors voted aye. The Board returned to open session. No action was taken.

Department head reports: Secondary Roads Update – Getting lots of highway buckling and are working on getting those fixed. Working on radios. Mechanic is back to work. Close to being done with contract rock. Road shoulders are in the process of being mowed. August 30th is set for a safety action plan meeting. A tube was replaced on 260th and a couple of driveways were installed. The shop is looking for a used fridge. A very small crew will be at work on Friday. Conservation – Have had a busy couple of weeks and everything is full. Friday, July 5th are the fireworks plus other activities at the lake including the youth scavenger hunt at 7 PM. Youth fishing will be held on Saturday. The department came in over revenue projections. IT – Reports of phishing and infiltrating systems has been on the rise especially in the areas of elections, so constantly monitoring and keeping patches updated. Auditor – The Iowa State Association of County Auditors went well. Working now on month-end and fiscal year-end plus cash balancing. The work will begin on taxes. Sheriff – TV caught fire on Saturday, last week participated in chase of bank robber that ended in Adams County.
