## **Board Minutes July 22, 2024**

The Adams County Board of Supervisors met on Monday, July 22, 2024, at 9:00 AM in the Adams County Court Room with the following members present: Tony Hardisty, Leland Shipley, Bobbi Maynes, Chris Standley, and Scott Akin. The meeting was called to order by Chairperson Akin at 9:00 AM. The Pledge of Allegiance was recited. Maynes moved, seconded by Hardisty to approve the agenda and the minutes of July 15 meeting. All supervisors voted aye. Motion carried.

Secondary Roads Update – Sign truck came in and received some training on it. Denco will be doing some bridge decking work yet this summer/fall on Quincy 9 bridge for around \$85,000. Been having lots of blowups with the really hot temps, so fixing those as they are reported. Received a complaint from the DNR on a resident using used motor oil as dust control on their gravel road. We worked with DNR on how to properly mitigate the situation and a letter was sent to the individual that they will be billed in the future for time spent by the Secondary Roads crew cleaning it up. DNR was pleased with the mitigation. Spoke with BNSF on some grants for RR crossings, however, in applying for those grants the county would have to eliminate some RR crossings. Phase 1 archaeological survey is underway for Colony 19. Working on shouldering projects due to all the rain washing shoulders away. Mechanic has been busy with several repairs to equipment. Two large culverts that are seven and eight feet in diameter are needing to be replaced, acquiring quotes for those.

Department Head Reports – Assessor – working on getting a P&Z budget put together and getting caught up on the Comp plan project as well as doing some training. Received our new flight maps so using the change finder tool to find any changes from the past three years that might have not been reported. Coming down to year end items and we'll be working on that. Still have some field work to complete after the tornado damage. This is a year for revaluations but feels the numbers are pretty accurate. Working towards his Iowa Certified Appraiser designation. Veterans Affairs received \$3,000 more dollars in state grant funds to go towards national training expenses. Conservation – Staying busy and mostly full at the lake. Travel Iowa is going to be out helping spruce up the trails where the triathlon will be taking place. Kayak program this week and a Scales and Tails program last week that was successful. Offering a Hunter Safety course for youth 12 years and older. Went to Audubon County to share tips on using My County Parks website. Working on REAP report. Fishing has been good at the lake; the catfish are plentiful. Auditor – Woking on Tax Statements.

Shipley moved, seconded by Standley to approve Final Voucher for Project FM-C002(79)—55-02 to close out the project. All supervisors voted aye. Motion carried.

## Resolution 2024-25

## A Resolution Authorizing Dale Kinser to Sign for All Items Not Requiring a Professional Engineer License

WHEREAS, the Adams County Board of Supervisors, recognizes the need for efficient and effective administration of county operations; and

WHEREAS, it is in the best interest of Adams County to designate an individual with the authority to sign documents that do not require the certification of a professional engineer;

NOW, THEREFORE, BE IT RESOLVED, by the Adams County Board of Supervisors as follows:

- 1. **Authority Granted:** Dale Kinser is hereby authorized and empowered to sign and execute all documents, forms, applications, permits, contracts, and other related items that do not require the certification or seal of a professional engineer on behalf of Adams County.
- 2. **Scope of Authority:** This authority includes, but is not limited to, routine administrative documents, maintenance agreements, and any other documents as deemed necessary for the efficient operation of Adams County.
- 3. **Duration of Authority:** This authorization shall remain in effect until revoked or amended by the Adams County Board of Supervisors.
- 4. **Effective Date:** This resolution shall take effect immediately upon its adoption.
