Board Minutes August 12, 2024

The Adams County Board of Supervisors met on Monday, August 12, 2024, at 9:00 AM in the Adams County Board Room with the following members present: Scott Akin, Tony Hardisty, Leland Shipley and Chris Standley. Bobbi Maynes participated via Zoom. The meeting was called to order by Chairperson Akin at 9:00 AM. The Pledge of Allegiance was recited. Hardisty moved, seconded by Standley to approve the agenda and the minutes of August 5 meeting. All supervisors voted aye. Motion carried.

Secondary Roads Update – Last week worked on planking bridges and got Grant 4, Jasper 12, and Lincoln 9 completed. Have now used up most of the planking on hand. Also worked on setting some metal culverts. The Adair County engineer came down and went over several projects that are ongoing. The mechanic is getting quotes and pricing on motor grader tires and other tires. Bill Lyddon assisted with the truck radios to help sort out frequencies so there is not as much interference. Will be having a hoist inspection this week. Working on prioritizing culvert replacements. Pipe for Hungry Canyons project was delivered today so work can start on that project most likely in September. The Mack work truck will be picked up today and the skid loader is back.

Hardisty moved, seconded by Shipley to purchase a skid steer planer attachment from Ziegler for \$20,089.25. All supervisors voted aye. Motion carried. The cost will be offset from the sale of equipment from Purple Wave Auction and the sale of the gravel rock retriever.

Department Head Reports – IT – An increase in election-related email attacks from foreign actors. Auditor – Taxes are done, election work has begun. The filing period for candidates is now open. Conservation – Have traded in the mower/trailer for a different one, the bent deck on another mower is being repaired, the UTV per insurance is totaled so will be looking for a replacement, camping is down at the moment is down due to the Iowa State Fair but overall is up from last year. Sherriff – Deputy Mullen's pickup is here and will be installing the dog cage in it. The drug dog has been deployed 14 times with 7 arrests.

Standley moved, seconded by Shipley to approve the claims as presented. All supervisors voted aye. Motion carried.

Deputy Mullen presented information on K9 training kits needed for the drug dog's continuing training. Hardisty moved, seconded by Shipley to approve purchase of the kits at a cost of approximately \$1000/year using opioid funding. All supervisors voted aye. Motion carried.

Shipley moved, seconded by Standley to place a public measure that was received by petition on the General Election ballot in November per Iowa Code 331.306. The Public Measure on the ballot pertains to Iowa Code 331.204 Membership reduced of Board of Supervisors. All supervisors voted aye. Motion carried.

Shipley moved, seconded by Hardisty to appropriate \$22,127.37 to Crossroads for Drug Prevention in Schools using Opioid Funding. All supervisors voted aye. Motion carried.

The appointment of a Title VI Coordinator has been tabled until next week.

Maynes moved, seconded by Hardisty to ask Planning and Zoning to begin researching a pipeline ordinance. Bobbi has several sample ordinances from other counties in the state that she will forward on. All supervisors voted aye. Motion carried.

The Board reviewed all of the changes one by one that had been made to the current draft of the Wind Ordinance to make sure everyone agreed on what had been discussed. Maynes moved, seconded by Hardisty to approve the Wind Ordinance draft of August 5, 2024. Voting aye: Akin, Hardisty, Maynes and Shipley. Voting no: Standley. Motion carried.

Hardisty moved, seconded by Shipley to set a Public Hearing for 10 AM on September 9, 2024, for the Proposed Wind Ordinance. All supervisors voted aye. Motion carried.

The Supervisors reported on various meetings that they had attended on behalf of the county including Courthouse Security. Scott informed the Board that we are now in the Mental Health Region located in Pottawatomie County.

Hardisty moved, seconded by Standley to adjourn the meeting at 10:18 AM. All supervisors voted aye. Motion carried.
