## **Board Minutes October 14, 2024**

The Adams County Board of Supervisors met on Monday, October 14, 2024, at 9:00 AM with the following members present: Scott Akin, Leland Shipley, Bobbi Maynes and Chris Standley. Tony Hardisty was absent. The meeting was called to order by Chairperson Akin at 9:00 AM. The Pledge of Allegiance was recited. Shipley moved, seconded by Standley to approve the agenda and the minutes of the October 7<sup>th</sup> meeting. All supervisors voted aye. Motion carried.

Secondary Roads Update – Quincy 4 is done and now open. Calhoun-Burns will be coming down to rate the bridge and then will look into the process of vacating the road. Have installed a culvert on 220<sup>th</sup> and will install culverts on 265<sup>th</sup> and Mulberry this week. The bat-wing mower went down and will be getting it fixed. Have had a lot of positive comments on mowing the roadways. Have posted the Maintenance I worker position and so far, have had two applicants. Have received a ROW permit from Mid-American for some radius turns for access to property in Union County. Nick, Adair County Engineer, was down this past week to look over the Hungry Canyon project on Orange Avenue of which there will be a meeting for approval from Hungry Canyons on Friday. Meet with FEMA on Thursday and are close to wrapping up with them. 200<sup>th</sup> Street detour with city received a lot of traffic and are going to try to water the road down and get it back into a satisfactory shape. Going to ask City to assist with 90 ton of rock to help with the process. Completed Reasonable Suspicion training which was good.

Shipley moved, seconded by Maynes to approve Utility Permit #24-06 for Massena Telephone Company. All supervisors voted aye. Motion carried.

Shipley moved, seconded by Maynes to approve Utility Permit #24-07 for CIPCO who is replacing an overhead line. All supervisors voted aye. Motion carried.

Shipley moved, seconded by Standley to approve the Secondary Roads Operations Manager Job Description. All supervisors voted aye. Motion carried.

Department Head reports: Conservation – Have started pulling buoys at the lake. Campgrounds are still being utilized and most likely will continue to be as long as the weather stays above freezing. Restrooms in the campgrounds will stay open through this weekend and then will start shutting them down except for the cottages and the self-contained cabins. The fish cleaning stations will also be shutting down. The policy has been that the lake stops taking reservations October 1 but the board is considering extending that date by a couple of weeks next year. The water level is down about 2-2 1/2 feet but not quite as low as last year. Travis and Marti attended the annual CCPOA 3-day training for recertification. EHD disease is prevalent and can be reported by individuals on the DNR website to obtain more documentation on the disease. Auditor – Becky was speaking to a group on Worker's Comp and Nancy reminded everyone that in-person absentee voting begins on Wednesday. Also, there is a new election tool on the county website to assist residents in locating their polling location.

Maynes moved, seconded by Standley to approve the claims as presented. All supervisors voted aye. Motion carried.
