

Board Minutes February 10, 2025

The Adams County Board of Supervisors met on Monday, February 10, 2024, at 9:00 AM with the following members present: Scott Akin, Leland Shipley, Tony Hardisty, Bobbi Maynes, and Chris Standley. The meeting was called to order by Chairperson Hardisty at 9:00 AM. The Pledge of Allegiance was recited. Akin moved, seconded by Standley to approve the agenda and the minutes of the February 3rd meeting. All supervisors voted aye. Motion carried.

Secondary Roads Update – Gave an update on the TIF projects. Working with Engineering to have projects ready to go. Will rent a skid loader and forestry head for \$2,500 from John Deere for 3 weeks to clear more ditches. Applied brine on highways. We went out for two days and applied sand and salt. There are weather forecasts for this week, and we are ready. Purple Wave auction items are ready to be placed on the auction site. Advertising for Colony 19 bridge plans and hopefully obtain good bids out of interest. Prescott 10 bridge is making progress. Last week we inspected the issue areas that the Army Corps has gotten involved with, but no progress has been made to remedy the issues. Planning to buy bridge planks so we are prepared for repairs when needed.
