The Adams County Board of Supervisors met on Monday, April 28, 2024, at 9:00 AM with the following members present: Tony Hardisty, Scott Akin, Leland Shipley, Bobbi Maynes, and Chris Standley. The meeting was called to order by Chairperson Hardisty at 9:00 AM. The Pledge of Allegiance was recited. Akin moved, seconded by Standley to approve the agenda and the minutes of the April 21<sup>st</sup> meeting. All supervisors voted aye. Motion carried.

Secondary Roads Update – Rock is available and weather permitting will be hauling contract rock. Doing core drills on Lincoln 3 & 4 bridges this week. Replacing a failed tube on 250<sup>th</sup> Street and Union Avenue today. Have all the products for the bridge replacement on 270<sup>th</sup> Street and should start at the end of this week. Then the crew will be moving to Mulberry Avenue for the Hungry Canyon Project. Received quote from Ten Point Construction for concrete patching and bridge approach repairs. Still working on siting safe driveways off old highway 34.
