WHEREAS, The Adams County Board of Supervisors deems it suitable that the 911 dispatchers listed above, currently employed by the Adams County Sheriff's Office are additionally viewed as process servers and allowed to serve any subject in the appropriate situation requested by a Plaintiff or its representative including but not limited to any of the following orders; Original Notice, Appearance and Answer, Dissolution of Marriage, Child Support Debt, Petition, Notice to Terminate Lease, 30 Day Eviction, Application to Show Cause, Affidavit, Financial Affidavit, Amended Orders, Answer to Petition, Appointment for Counsel, Notice to Cure Default, Summons, Family Law Requirements, Motion to Continue, Notice of Support Debt, Order, Order to Appear, Petition at Law, Verification, or any other Order signed by an Honorable Judge in the State of Iowa or Nation of Unites States requested to be served in Adams County Iowa; excluding Ex Partes, Temporary Protection Orders, Warrants, all Subpoenas.

RESOLVED, The Adams County Board of Supervisors resolves above request by approving the above listed individuals who are currently employed by the Adams County Sheriff's Office to serve civil paperwork while fulfilling Sheriff Office duties when called upon at times an officer is unavailable or at emergency calls. It is duly noted that if any of the above names approved in this resolution become unaffiliated with the Adams County Sheriff's Office in the future this agreement in regards to that name is hereby severed, and that individual shall not by any means be allowed to serve any civil paper in the name of Adams County Sheriff's Office.
