Treasurer – Delinquent taxes were published in the paper last week, so we’re starting to receive a few more tax payments. We are at 99.63% collected with around \$92,000 left to collect. IT – Working on Solutions contract. Conservation – Quiet holiday weekend at the lake. Very little beach and boating activity with the cold rainy weather. All docks and buoys are in, but the lake is still two feet low. Docks and ramps on the north side of the lake are the safest at this time. Still having sewer issues. Roof hail damage from last year will be fixed soon. Hosted an amazing mushroom program at the lake this past weekend. The archery range will be open every Wednesday from 6-7 pm throughout the summer. People can bring their own gear, or we will have some they can use. The National Guard sendoff parade for troops is tomorrow at 9 am. A couple more seasonal employees will be starting this week.
