The meeting was called to order by Chairperson Hardisty at 9:00 AM. The Pledge of Allegiance was recited. COMPENSATION FOR RIGHT-OF-WAY AND TEMPORARY EASEMENT PURCHASE

WHEREAS, it is sometimes necessary for Adams County to obtain additional right-of-way and/or temporary easement in order to construct improvements to the Secondary Road system;

AND WHEREAS, there is a need to establish a level of compensation for such newly acquired right-of-way and/or temporary easement;

AND WHEREAS, recent sales of agricultural land within Adams County have been made at an average of 5.49 times the county assessor's valuation of the land;

BE IT RESOLVED, that Adams County hereby establishes the rate of <u>5.49</u> times the county assessor's valuation of the land portion of the parcel to which the newly acquired right-of-way was a part and ALSO hereby establishes the rate of <u>.549</u> times the county assessor's valuation of the parcel to which the temporary easement was a part of, with no payment for a single temporary easement equaling less than \$200.00.

Discussion on the Cummins Diesel service contract renewal has been tabled.

Sheriff Johannes will reach out to Simmons Restoration again to remove asbestos. We will need to reroute dispatch while the asbestos is removed. Hardisty will also ask SCI 911 if there is assistance in rerouting dispatchers.

Discussion was held on ISAC 99 county tour visit. Maynes will contact them to schedule for a Monday morning.

The Board of Supervisors, under the authority of the 2025 Code of Iowa, formed a canvassing board to check the returns of the City/School held on November 4, 2025. The findings, thereof, are recorded at length in Election Book #8 in the Adams County Auditor's Office as required by Section 50.27 of the 2025 Code of Iowa. No obvious clerical errors were identified during the canvass and there were no absentee ballots that were rejected and not counted. A total of 517 votes were cast in Adams County.
