

## Board Minutes January 2, 2026

The Adams County Board of Supervisors met on Friday, January 2, 2026, at 9:00 AM with the following members present: Scott Akin, Leland Shipley, Chris Standley, and Tony Hardisty. Bobbi Maynes was absent. The meeting was called to order by Auditor Stormer at 9:00 AM. The Pledge of Allegiance was recited. Standley moved, seconded by Akin to approve the agenda and the minutes of the December 22<sup>nd</sup> and December 23<sup>rd</sup> meetings. All supervisors voted aye. Motion carried. There were no public comments.

RESOLUTION #2026-2

CONSTRUCTION EVALUATION RESOLUTION

WHEREAS, Iowa Code section 459.304(3) sets out the procedure if a board of supervisors wishes to adopt a “construction evaluation resolution” relating to the construction of a confinement feeding operation structure; and

**WHEREAS,** only counties that have adopted a construction evaluation resolution can submit to the Department of Natural Resources (DNR) an adopted recommendation to approve or disapprove a construction permit application regarding a proposed confinement feeding operation structure; and

**WHEREAS,** only counties that have adopted a construction evaluation resolution and submitted an adopted recommendation may contest the DNR’s decision regarding a specific application; and

**WHEREAS,** by adopting a construction evaluation resolution the board of supervisors agrees to evaluate every construction permit application for a proposed confinement feeding operation structure received by the board of supervisors between February 1, 2026 and January 31, 2027 and submit an adopted recommendation regarding that application to the DNR; and

**WHEREAS,** the board of supervisors must conduct an evaluation of every construction permit application using the master matrix created in Iowa Code section 459.305, but the board’s recommendation to the DNR may be based on the final score on the master matrix or may be based on reasons other than the final score on the master matrix;

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF ADAMS COUNTY** that the Board of Supervisors hereby adopts this construction evaluation resolution pursuant to Iowa Code section 459.304(3).

Akin moved, Shipley seconded to approve Resolution 2026-2 Construction Evaluation – Master Matix. All supervisors voted aye. Motion carried. Attested by the Auditor. The full resolution is on file in the Auditor’s Office.

**Resolution 2026-3**  
**ADAMS COUNTY RESOLUTION ADOPTING DOCUMENTS PERTAINING TO COMPLIANCE WITH TITLE VI PROVISIONS OF THE CIVIL RIGHTS ACT OF 1964**

**WHEREAS,** Adams County has been a recipient of federal financial assistance from the U.S. Department of Transportation; and

**WHEREAS,** in receiving such financial assistance Adams County is mandated to comply with the provisions of Title VI of the Civil Rights Act of 1964; and

**WHEREAS,** the Iowa Department of Transportation has directed Adams County to adopt certain documents and put certain procedures in place in order to comply with the Title VI of the Civil Rights Act of 1964; and

**WHEREAS,** in order to continue receiving federal financial assistance form the U.S. Department of Transportation the adoption of certain documents and establishment of certain procedures is necessary.

- NOW THEREFORE BE IT RESOLVED** by the Adams County Board of Supervisors that:
1. The Adams County Operations Manager is hereby designated Title VI Coordinator for Adams County.
  2. The Adams County Title VI Agreement is hereby adopted and that the Chairman of the Board of Supervisors and Title VI Coordinator are authorized to sign said plan where required.
  3. The Standard Iowa DOT Title VI Assurances are hereby adopted and that the Chairman of the Board of Supervisors is authorized to sign said document where required.
  4. The Title VI Notice to the Public is hereby adopted and shall be posted where other public notices are displayed in the Adams County Courthouse and Adams County Engineer’s Office. Furthermore, said notice shall be posted on the official Adams County website.
  5. The Title VI Coordinator is authorized to take any other actions necessary and/or recommended by the Iowa Department of Transportation, U.S. Department of Transportation, or other designated authority to comply with the provisions of Title VI of the Civil Rights Act of 1964.

**Resolution 2026-6**

**AUTHORIZING PERSONNEL TO ISSUE PERMITS**

**WHEREAS**, the Board of Supervisors is empowered under authority of Sections 321.1 of the Code of Iowa to issue permits for the movements of machines, vehicles, or loads, or combinations thereof which exceed the maximum dimensions and/or weights specified in Section 321.452 to 321.466 but within limitations of Chapter 321E upon Secondary Roads under its jurisdiction, and,

**WHEREAS**, it is important that such permits be issued by persons familiar with the statutes and regulations relating to such permits and also with limitations of the county’s roadways, road surfaces, and structures along the selected or designated routes,

**NOW, THEREFORE BE IT RESOLVED** by the Adams County Board of Supervisors that the Adams County Engineer, Nick Kauffman, P.E., and the following named employees of the Secondary Roads Department (Carter Brehm, Dale Kinser, Gary Johnston and Karen Carl) be authorized to issue and sign special permits for movement of vehicles of excessive size and weight upon Adams County secondary roads in accordance of said Chapter 321E.

**Resolution 2026-7**

**A Resolution Authorizing Dale Kinser to Sign for All Items Not Requiring a Professional Engineer License**

**WHEREAS**, the Adams County Board of Supervisors, recognizes the need for efficient and effective administration of county operations; and

**WHEREAS**, it is in the best interest of Adams County to designate an individual with the authority to sign documents that do not require the certification of a professional engineer;

- NOW, THEREFORE, BE IT RESOLVED**, by the Adams County Board of Supervisors as follows:
- 1. **Authority Granted:** Dale Kinser is hereby authorized and empowered to sign and execute all documents, forms, applications, permits, contracts, and other related items that do not require the certification or seal of a professional engineer on behalf of Adams County.
  - 2. **Scope of Authority:** This authority includes, but is not limited to, routine administrative documents, maintenance agreements, and any other documents as deemed necessary for the efficient operation of Adams County.
  - 3. **Duration of Authority:** This authorization shall remain in effect until revoked or amended by the Adams County Board of Supervisors.
  - 4. **Effective Date:** This resolution shall take effect immediately upon its adoption.

**Resolution 2026-8**

**ADAMS COUNTY SECONDARY ROADS  
DESIGN AND CONSTRUCTION POLICY**

**BE IT RESOLVED**, that the Adams County Board of Supervisors adopts the following policy concerning the design and construction of new and/or reconstructed bridges and culverts for the Secondary Road System:

Bridge roadway widths are to comply with the requirements set out in the current AASHTO Design Guides and/or current design guides established by the Iowa Department of Transportation. The minimum width of low water crossings on dirt (unsurfaced) roads will be 18 feet.

Culverts, with the exception of low-water crossings, and bridges are to be sized to accommodate, as a minimum, the runoff from the flood frequency shown below:

On Level C or B Service roads, 10-year reoccurrence frequency  
On Level A Service, granular surfaced roads, 25-year reoccurrence frequency

On paved roads, 50-year reoccurrence frequency, checked for 100 year reoccurrence frequency.

Design flows are to be selected from the “Iowa Runoff Chart” for drainage areas less than 2 square miles, and from the appropriate formulae shown in the USGS Scientific Investigation Report 2013-5086, for drainage areas in excess of 2 square miles.

Akin moved, seconded by Shipley to approve Resolution 2026-8 Adams County Secondary Roads Design and Construction Policy. Ayes: Shipley, Hardisty, Akin, Standley. Nays: none. Absent: Maynes. Motion carried. The full resolution is on file in the Auditor’s office.

**Resolution 2026-09**  
**COMPENSATION FOR FENCE**

**WHEREAS**, it is sometimes necessary to remove fences to construct projects at locations where additional county road Right-Of-Way has been acquired;

**AND WHEREAS**, the landowners incur added expense for the replacement of this fence on the property outside of the newly acquired Right-Of-Way;

**AND WHEREAS**, Adams County will compensate the landowners from whom additional Right-Of-Way has been obtained at the rate of **\$ 65.00 per rod** for fence of any type that is removed due to the purchase of said new Right-Of-Way. In addition Adams County will compensate the landowners **\$ 150.00 per post** for each additional cornerpost/bracepost combination needed to construct the new fence because of the changes in the fence alignment due to the new construction as determined by the proposed plans.

**UTILITY, TELECOMMUNICATION PERMITS**

**BE IT RESOLVED** by the Adams County Board of Supervisors, that effective January 1st, 2026, Nick Kauffman, P.E., Adams County Engineer, be and is hereby designated, authorized, and empowered on behalf of the Adams County Board to execute utility and telecommunication permits on the county Right-of-Way through calendar year 2026,

**HOWEVER**, if Engineer Nick Kauffman is absent, Carter Brehm, the Assistant Engineer approve all utility and telecommunication permits.

Akin moved, seconded by Shipley to approve Resolution 2026-10 Designation of County Engineer to Authorize Utility, Telecommunication Permits. Ayes: Shipley, Hardisty, Akin, Standley. Nays: none. Absent: Maynes. Motion carried. The full resolution is on file in the Auditor’s office.
